Terms and Conditions of the Sale.

1. The purchase price of this pure bred American Pit Bull Terrier is \$ _____ and will be paid via _____ to Double L Kennels The purchaser has the full registration rights to register with the all registries mentioned.

2. The American Pit Bull Terrier is registered or has the opportunity to be registered with the APBR. Other registries available to be registered with are: _____

3. The purchaser is responsible for all other registrations

4. (Health Guarantee) This American Pit Bull Terriers health is Guaranteed for a period of _____ months to the original purchaser to be free of serious infection, disease or defect. If in allotted period of time the American Pit Bull Terrier does not meet this health guarantee the purchaser will be eligible for another American Pit Bull Terrier of equal price or higher if that is the case. If Double L Kennels do not have any puppies at the time of return a refund will be awarded. We require a signed and notarized form for a licensed Veterinarian stating breed, age, history of care and diagnosis. We withhold the right to have a second opinion from a Veterinarian of our choosing, if a discrepancy arises between your vet and my vet we will get a third Veterinarian of mutual choice to do the final examination, at the purchasers cost.

5. Purchaser must have the American Pit Bull Terrier examined within 3 days after delivery by a qualified Veterinarian Clinic. A full refund will not be awarded due to injury after delivery, illness from change of environment, neglect, abuse, or skin related problems commonly associated with the blue skin color of some of our American Pit Bull Terrier. If returned upon examination Double L Kennels

reserves the right to keep the puppy for up to two weeks at purchasers expense.

6.Purchaser must provide responsible and adequate confinement as to prevent escape or harassment to the public or possible injury to the community so as to further amplify the common negative stereotypes about American Pit Bull Terriers.

7.Purchaser must agree to provide adequate food, water, shelter, health care, socialization and exercise. Obedience training is recommended but not required.

8.Purchaser must update Double L Kennels about the health care of the American Pit Bull Terrier, and provide us with periodic pictures as the puppy grows and changes.

9.Purchaser must let Double L Kennels know if they are unable for any reason to keep their American Pit Bull Terrier or if the purchaser is going to sell the puppy/dog. We also reserve the right to place that dog before it gets sold or taken to shelter, Aspcra, etc.. If we are not able to find a suitable home and cannot take the dog ourselves the purchaser must find a no-kill shelter to take the puppy/dog. Due to the perception and almost certain death at any other shelter.

10.Purchaser will notify Double L Kennels before selling the American Pit Bull Terrier to a third party.

11.Purchaser will notify all registered organizations when selling to a third party.

12.Purchaser must notify Double L Kennels and registered organizations about life threatening or debilitating diseases, also and problems had giving birth or bearing pups with diseases or defects.

13.All deposits and final payments are non-refundable but are transferable to a different puppy or adult American Pit Bull Terrier of the same price from Double L Kennels. The purchaser must have paid in full including the cost of the American Pit Bull Terrier and associated costs by 8 weeks of age or the purchaser forfeits their pick. If the puppy may not be picked up until week 6 but if it is not picked up by week 8 Double L Kennels reserves the right to charge a 10 dollar a day boarding charge for each day up to the age of 12 weeks. If the puppy is not picked up by the end of week 12 the purchaser forfeits the puppy at which time Double L Kennels reserves the right to sell the puppy to another client.

14.If the purchaser is found to be dog fighting or associated with any kind of dog fighting organization or is found to have been previously convicted of dog fighting Double L Kennels reserves the right to confiscate any American Pit Bull Terriers purchased from us. Purchaser will also be responsible for all expenses that accompany the confiscation.

15.If the purchaser is found to be abusing or neglecting, any kind of animal cruelty or has been convicted of animal cruelty, Double L Kennels reserves the right to confiscate any American Pit Bull

Terriers purchased from us. Purchaser will also be responsible for all expenses that accompany the confiscation.

16.If the American Pit Bull Terrier being purchased is a part of an outhouse breeding, the health guarantee is void. Double L Kennels will not knowingly sell a puppy with something wrong with it, however we will not guarantee a puppy when we did not oversee the dam while pregnant or the whelping so we cant guarantee the health of the puppy. Double L Kennels only guarantee American Pit Bull Terrier puppies that were bred, overseen, and whelped at Double L Kennels.
